In partnership with the community, we pledge to:



QUALIFICATIONS & **SCREENING**

Men & Women seeking employment as Sheriff's Deputies must have a high school education or GED equivalency, and be at least 18 years of age.

Tests are given as needed and will be advertised in the legal section of newspapers and on social media accounts @KanawhaSheriff. Applications can be accepted anytime, and applicants will be notified of upcoming test dates.

Applicants are first required to participate in and pass a physical ability test that consists of:

- 18 Push-Ups (1 Minute)
- 28 Sit-Ups (1 Minute)
- 1.5 Mile Run (14 Minutes & 36 Seconds)

Following the physical ability test, applicants who pass will then complete a written test that will be administered by the Kanawha County Deputy Sheriff's Civil Service Commission. Applicants must score a 70% on this written test. Prior or existing members of the US Military and Certified WV Law Enforcement can receive extra points on their final test score. Upon completion of the written test, applicants will be required to undergo additional physical and psychological tests.

These tests include, but are not limited to:

- Physical Examination
- Background Investigation
- Polygraph Examination
- Psychological Examination
- Interview with the Senior Staff of the Kanawha County Sheriff's Office

TRAINING

Upon appointment, applicants are hired at the rank of deputy and undergo paid training at the West Virginia State Police Academy in Institute, WV, for a period of 16 weeks with the option to come home on the weekends. Your training will be a combination of both physical training and classroom studies covering all areas needed to become a certified Law Enforcement Officer in the State of West Virginia. Exceptions are made to out-of-state certified officers on a case-by-case basis.

Upon graduation from the WVSP Academy, deputies are required to complete a one-year probationary period from the date of employment. During this period, deputies will participate in a five-phase, nineteen-week Field Training Program.

The goal of the Field Training Program is to produce betterprepared and better-trained deputies by exposing them to inthe-field training and real-life scenarios while under the direct supervision of experienced Field Training Officers (FTOs). This will aid in the deputy's ability to learn gradually and to deal with the rigors of the profession before being allowed to work on their own.

SALARY
